**Eligibility:** All customers served by Bolick Distributors are eligible to participate.

**Enrollment:** Any customer wishing to participate in this program must complete an enrollment form and place a non-refundable deposit of \$250 per couple.

<b>Trip Costs:</b>	Double Occupancy:	27,100 points per couple
	Single occupancy:	19,000 points per person
	Third person, as adult:	11,900 points per person <i>(Age 17 years and older.)</i>
	Third or fourth person, as child:	8,600 points per person <i>(Age 16 years and younger.)</i>
	Additional Nights:	3,000 points per night <i>(Includes airport transfer.)</i>

**Early Enrollment Child Discount:** All customers who wish to bring children will receive a discount of \$400 (1,600 points) per child off the regular cost for Triple/Quad passengers 16 years and younger. **Enrollments must be received prior to October 31, 2017.**

**Additional Trips:** There is no limit to the number of trips you may earn.

**Buy-in Option:** Should your trip fund not fully cover the cost of your trip, you may “Buy-in” for the unearned portion as long as you are at least 50% qualified at the end of the qualification period.

**Qualification Period:** September 1, 2017 – December 31, 2018 *(16-month qualification period.)*

**Travel Dates:** Thursday, March 14 - Monday, March 18, 2019

**Entry Requirements:** All U.S. citizens *(adults and children)* must have a round-trip airline ticket and valid U.S. Passport to travel. Non-U.S. citizens should contact their local consulates for entry requirements into Mexico.

**Cancellations:** Any customer wishing to drop out of this program may do so. Any cost incurred by Bolick Distributors as a result of cancellation will be deducted from your point fund or invoiced to you if your point fund does not cover. Your balance will be credited to your account, but Bolick Distributors points contributed (including Auto and Bonus Points) are not refundable and may not be used to cover any cancellation charges.
